The Ottawa Police Service asked if assistance could be provided to ensure everyone was safe while moving my niece out of her apartment. We were advised to contact the main non-emergency number when we arrived in Ottawa. We made that contact and were advised that they would have an officer meet us in a few minutes. We were met by Cst. Joshua White and Cst. Angus (sorry I didn't get his first name). Both officers were professional and courteous and listened and got all the facts from the preceding evening and what we were trying to accomplish while at the apartment. They attended the door and spoke with my niece's "boyfriend" and had them vacate the premises while we moved our nieces belongings out and into the moving truck. The exercise took us approximately 90 minutes and the officers stayed onsite during that time to ensure everyone was safe and there were no further issues.

We did not want the understanding and cooperation of the Ottawa Police Service, Constables White and Angus to go unnoticed. The professionalism that these two young officers exhibited to a distraught female and her concerned family was second to none. They represented your police service and the city extremely well and they should be proud of their conduct.

Excerpt from Letter: If you recall, my cousin was the young non-verbal autistic boy who fell from a 5th story window. Upon your arrival to the scene, my cousin was in critical condition and our entire family was in complete shock at what had occurred. Your efforts to save his life as well as supporting his mother never went unnoticed and we are forever grateful to each and every one of you.

Following the accident, my cousin remained in hospital for almost three months, one of which was in the ICU. He unfortunately suffered extensive brain damage from the fall resulting in seizures, as well as multiple bone fractures. The injuries from the accident left my cousin unable to walk or eat independently but, due to the dedication of the team at CHEO, he underwent extensive rehabilitation and was discharged in mid-September 2020.

I am pleased to report that, as of today, my cousin is home with his family, living as a happy 8-year-old boy. Though he is still predominantly wheelchair bound, he has regained the ability to stand and take a few steps. He has also relearnt how to drink fluids and eat some solid foods.

On behalf of our entire family, and especially his parents, I would like to thank you all for playing such an immense role in saving his life. We truly believe he wouldn't be here today had it not been for your work. Thank you.
