## **BACKGROUND**

Ottawa Public Health is an active member of the Association of Local Public Health Agencies (alPHa). alPHa provides leadership to boards of health and public health units in Ontario as well as advises and lends expertise on the governance, administration and management of health units. The Association also collaborates with governments and other health organizations, advocating for a strong, effective and efficient public health system in the province. Membership includes Board of Health Members, Medical Officers of Health and Associate Medical Officers of Health, as well as senior public health managers and affiliate members.

Participation in alPHa meetings is strongly encouraged, including by the Medical Officer of Health and/or Associate Medical Officers of Health and, whenever possible, Members of the Board of Health. alPHa regularly holds three meetings a year, including a Fall and Winter Symposium as well as the Annual General Meeting and Conference.
