CARRIED. COUNCILOR EL-CHANTIRY HAS A DIRECTION OF INTEREST. COUNCILOR, PLEASE?>> THANK YOU. THANK YOU. MAYOR.AND THIS WOULD BE IN EFFECT FOR A YEAR.THIS INTERIM CONTROL BYLAW IS BEING INTRODUCED TO RESPOND TO SERIOUS CONCERNS FROM THE CITY AND FROM AFFECTED COMMUNITIES ON HOW DEVELOPMENT IS OCCURRING WITHIN ESTABLISHED INNER CITY COMMUNITIES.ESTABLISHED COMMUNITIES ARE MEANT TO ACCOMMODATE A GRADUAL EVOLUTION OVER TIME AND ARE NOT MEANT TO BE THE FOCUS FOR INCOMPATIBLE INTENSIFICATION ACTIVITY. OTHER NEIGHBOURHOODS ACROSS THE CITY.WE'RE ALSO REAFFIRMING COUNCIL'S COMMITMENT TOWARDS FINALIZING THIS STUDY TO ENSURE DEVELOPMENT OCCURS IN A GRADUAL, RESPECTFUL MANNER IN OUR ESTABLISHED COMMUNITIES AND KEEPING WITH THE VISION OF OUR OFFICIAL PLAN.SO, THE MOTION TODAY SPEAKS TO THAT, AND I THINK YOU HAVE IT BEFORE YOU.DO YOU?YEP?THERE, BE IT RESOLVED THAT THE ONGOING R-4 STUDY BEING UNDERTAKEN BY THE PLANNING INFRASTRUCTURE AND ECONOMIC DEVELOPMENT DEPARTMENTING DEEMED A STUDY REQUIRED TO BE DIRECTED BY COUNCIL PURSUANT TO SECTION 38 OF THE PLANNING ACT IN RESPECT OF THE LAND USE PLANNING POLICIES ASSOCIATED WITH LOW RISE SINGLE DETACHED AND MULTIPLE UNIT DWELLINGS.ESTABLISH BE FURTHER ZONING STANDARDS TO HELP ENSURE THEIR CAPABILITY AND THAT THE STUDY BE EXPANDED TO INCLUDE ARE, 1, 2 AND 3 ZONE LANDS WITHIN THE STUDY AREA.AND BE IT FURTHER RESOLVED. AS BEING SEE ON THE SCREEN, THAT COUNCIL ENACT AN INTERIM CONTROL BYLAW TO APPLY TO ALL RESIDENTIAL R1, R2 AND R3 ZONES IN THE AREA DEFINED ON THE MAP ATTACHED TO THIS MOTION.SO YOU'LL SEE -- YOU DO HAVE IT BEFORE YOU.I THINK YOU HAVE PRINTED COPIES BEFORE YOU.AND NO DWELLING UNIT IN ANY BUILDING OTHER THAN A SINGLE DETACHED DWELLING MAY CONTAIN MORE THAN FOUR BEDROOMS AND NO SUCH UNIT MAY EXCEED 120 METRES SQUARED IN FLOOR AREA.TWO, THAT NO SINGLE DETACHED DWELLING MAY CONTAIN MORE THAN SIX BEDROOMS.THREE, NO MULTI-UNIT DWELLING WITH SIX DWELLING UNITS OR FEWER MAY EXCEED A TOTAL FLOOR AREA OF 500 METRES SQUARED MEASURED FROM THE INSIDE OF THE EXTERIOR WALLS, INCLUDING ANY BASEMENT, MOTOR VEHICLE STORAGE AREA OAR ANY OTHER BUILDING AREA, AND, FOUR, NOTWITHSTANDING THE ABOVE, A DEVELOPMENT THAT WE DEALT WITH ON-SITE PLAN YESTERDAY AT PLANNING COMMITTEE LOCATED AT 70 RUSSELL ROAD IS NOT SUBJECT TO THESE REGULATIONS.AND THAT'S THE MOTION.THANK YOU.>> THANK YOU VERY MUCH, COUNCILOR FLEURY. ON THE MOTION, PLEASE?(SPEAKING FRENCH)>> (VOICE OF TRANSLATOR): THANK YOU. CHAIR, I'D LIKE TO THANK THE COMMITTEE'S CHAIR FOR HER LEADERSHIP ON THIS ISSUE.I'D LIKE ALSO TO TALK ABOUT THE GOOD WORK OF CITY STAFF OVER THE PAST YEARS, BE IT FOR CONVERSIONS OR THAT HAS TO DO WITH IN-FILL ONE AND TWO.I THINK THAT SOME CONSIDERABLE EFFORTS WERE PUT FORWARD.AT LAST COUNCIL. WE HAD THE SPECIFIC REPORT FOR SANDY HILL REGARDING THE GARBAGE. HAD AN IMPACT ON THE BYLAW.WE BROUGHT SOME AMENDMENTS ALSO FOR THE NOISE.IT'S NOT AN ISSUE THAT SPECIFICALLY APPLIES TO SANDY HILL. BUT BECAUSE IT IS CLOSE TO THE UNIVERSITY OF OTTAWA, WE COULD FEEL THE IMPACT OF WHAT WE CALL USUALLY A BUNKHOUSE, WHAT THE COMMUNITY COULD DECLARE AS A LEGAL ROOMING HOUSE, AND TODAY, WHAT WE HAVE IN FRONT OF US IS A VERY SERIOUS APPROACH TO GET TO A SOLUTION, A REVIEW OF R4 ZONE.SO I THINK WE ARE IN -- IN THE RIGHT DIRECTION.WE WILL DO THE STUDY FOR THE R4 ZONE, BUT WE NEED TO BE ABLE TO CORRECT THE CURRENT DYNAMICS, AND THAT'S WHAT THE AMENDMENT IS PROPOSING TO DO RIGHT AWAY.SO I'D LIKE TO ASK MEMBERS OF COUNCIL TO SUPPORT THIS MOTION. MANY COMMUNITIES HAVE BEEN MENTIONED, BECAUSE THEY SEEM TO BE AFFECTED BY THESE DEVELOPMENT IMPACT OF THOSE BUNKHOUSES.SO I'D LIKE TO THANK THE CHAIR FOR HER SUBMISSION TODAY.>> THANK YOU.>> THANK YOU VERY MUCH.I LIKEWISE WOULD LIKE TO THANK OUR STAFF FOR PREPARING THIS MOTION AND TO CHAIR HARDER.I WAS PLEASED TO LEARN THAT IT WAS GOING TO BE COMING FORWARD TODAY AND I KEPT MY MOUTH SHUT, BECAUSE THAT'S WHAT WE HAVE TO DO WITH INTERIM CONTROL BYLAWS IN ORDER NOT TO JEOPARDIZE THE STATUS OR ADVANCE SORT OF INSIDER TIPS TO PEOPLE IN A MAY BE AFFECTED.I DON'T SUPPORT AN INTERIM BYLAW LIGHTLY.WE'VE ONLY USED ONE ONCE IN MY SEVEN YEARS IN COUNCIL. I BELIEVE.AND ALL YOU WOULD HAVE TO DO IS SEE SOME OF THE PHOTOS OR COME UP AND LOOK AND HAVE ONE OF THOSE HOLY -- AND YOU CAN FILL IN THE BLANKS WHAT WORD I PROBABLY SHOULDN'T SAY IN PUBLIC THERE, WORD WHAT YOU WOULD USE WHEN YOU LOOK AT ONE OF THOSE BUILDINGS.IT'S A LITTLE DECEPTIVE WHEN YOU SEE SOME OF THE VERBIAGE IN THIS MOTION, WHEN YOU SEE FOUR BEDROOMS PER UNIT.WHAT WE'RE TALKING ABOUT AT THE MOMENT IS FOUR, FIVE OR SIX BEDROOMS PERFECT UNIT, BUT THE UNIT IS ONE FLOOR OF A BUILDING.PICTURE A DIE ATTACHED ORDINARY DWELLING IN OLD OTTAWA SOUTH OR OVER BROOK OR ELSEWHERE THAT HAD A FAMILY OF WHO KNOWS.MAYBE IT WAS A BIG FAMILY ONE DAY.MAYBE THERE WERE SIX OR SEVEN PEOPLE WHO LIVED THERE AT ONE POINT BERGS IT WAS ONE SET OF GARBAGE.IT WAS ONE FAMILY'S WORTH OF VEHICLES.IT WAS ONE FAMILY'S WORTH OF ACTIVITY AND NOISE.NOW YOU HAVE EACH FLOOR OF WHAT IS A MASSIVE RECTANGULAR TYPICALLY UGLY BUILDING BEARING NO RELATIONSHIP TO THE NEIGHBOURHOOD IN THE MIDDLE OF A BLOCK OF TRADITIONAL HOMES FOR THAT AREA, WHERE EACH FLOOR HAS FOUR, FIVE

OR SIX RESIDENCE. TYPICALLY UNRELATED. NOT COOPERATING IN IN THE USE OF THEIR GARBAGE OR THEIR GREEN BIN ON THEIR RECYCLING. VERY OFTEN NOT PARTICIPATING IN ANY OF THOSE.THEY DON'T KNOW HOW.THEY'RE NOT COLLABORATING.SO, EVEN IF THEY MANAGE TO GET THE COLLECTION DAY RIGHT AND NOT PUT THE WRONG BINS OUT AND NOT PUT THE BAGS OUT WHEN IT ISN'T ACTUALLY THE WEEK FOR GARBAGE COLLECTIONER WHICH OBVIOUS DON'T, YOU WILL HAVE 16, 18, 20 GARBAGE BAGS OUT ON A NON-EXISTENT FRONT LAWN.JUST IMAGINE IF YOU GOT THE WEEK WRONG AND THE OTHER URBAN DWELLERS GOING BY THE NAME OF SQUIRREL. RACCOON. SKUNK AND OTHERWISE GOT INTO THOSE, I HOPE I'VE PAINTED A PICTURE FOR YOU OF WHAT WE'RE REALLY DEALING WITH HERE.WE KNOW --WE KNOW THAT IN-FILL DEVELOPMENT IS COMING. YOU'VE HEARD THE REFRAIN IN EVERY PLANNING COMMITTEE MEETING.I'M NOT AGAINST IN-FILL BUT -- AND THIS IS A SERIOUS "BUT" -- AND SO THIS IS A CHANCE FOR US TO PUT A STOP TO THE WORST FOR A SHORT PERIOD OF TIME, TO GET THE RULES ADJUSTED.AGAIN, THESE ARE CLEVER PEOPLE WHO WANT TO MAKE MONEY.THEY EACH -- EACH TIME WE CREATE A NEW SET OF RULES, WE FIND WAYS TO GET AROUND THEM, AND WE HAVE TO RESPOND, BECAUSE LIKE DOPING IN SPORTS, YOU NEVER KNOW WHAT THE NEXT ONE IS GOING TO BE.ALL YOU CAN DO IS RESPOND TO IT ONCE IT'S THERE.AND THIS IS THE NEXT RESPONSE.I HOPE SOME DAY WE'LL RUN OUT OF -- THEY'LL RUN OUT OF OPTIONS AND WE WON'T HAVE TO KEEP DOING THIS, BUT THIS IS THE LATEST AND I'M PLEASED TO FOR.THANK YOU.>> THANK YOU VERY MUCH.COUNCILOR NUSSBAUM, PLEASE.>> THANK YOU VERY MUCH, MR. CHAIR.I CAN SIMPLY ECHO MY APPRECIATION TO STAFF AND TO COUNCILORS HARDER AND FLEURY FOR BRINGING THIS FORWARD.MUCH OF WHAT THE COUNCILOR SAID IS TRUE IN TERMS OF NOT TAKING THIS ISSUE LIGHTLY, BUT ALSO RECOGNIZING THE VALUE AND HAVING SOMETHING IN PLACE WHILE THE R4 REVIEW IS UNDERWAY.AND TO THAT AFFECT. JUST A COUPLE OF QUICK QUESTIONS TO STAFF: CERTAINLY WELCOME THE SUGGESTION HERE THAT WE WIDEN THE R4 STUDY TO INCLUDE R1, R2 AND R3 ZONED LANDS WITHIN THE STUDY AREA.I'M JUST WONDERING IF THERE'S GOING TO BE FLEXIBILITY ON STAFF'S PART TO ADJUST THE STUDY AREA BORDERS, BECAUSE WITH THE CONCLUSION OF THOSE THREE OTHER R ZONES, THERE MAY BE A NEED TO INCLUDE AREAS THAT WERE NOT CONSIDERED AS PART OF THE R4 STUDY BECAUSE THE R4 STUDY WAS FOCUSED ON R4.>> MR. DEPUTY MAYOR, THE ANSWER TO THE QUESTION IS MOST CERTAINLY FROM

THE PERSPECTIVE OF THE R4 STUDY, WHICH WILL NOW PROBABLY BE RENAMED. WE CAN ADDRESS THE GEOGRAPHIC BOUNDARIES WITHIN THE STUDY.HOWEVER, JUST TO BE CLEAR THAT THE INTERIM CONTROL BYLAW BOUNDARIES ARE SET THROUGH THIS PROPOSED BYLAW.>> YEAH.THAT IS UNDERSTOOD.AND JUST SO THAT -- OBVIOUSLY THIS IS GOING TO AFFECT THE PUBLIC CONSULTATION ELEMENT OF THE STUDY. THE TIMELINES. COULD STAFF PERHAPS JUST GIVE US A ROUGH INDICATION OF HOW THE STUDY PERIOD WILL BE CHANGED? PRESUME THAT THE IDEA WILL BE TO BRING BACK THE RESULTS OF THAT STUDY WITHIN 12 MONTHS SO THAT WE'RE IN A POSITION TO IMPLEMENT THE STUDY RECOMMENDATIONS BEFORE HAVING TO DEAL WITH THE POTENTIAL RENEWAL OF THE INTERIM CONTROL BYLAW.>> MR. DEPUTY MAYOR, I'LL START WITH THE ANSWER.OUR INTENT ACTUALLY IS TO COME BACK TWICE TO PLANNING COMMITTEE ON THIS MATTER.WE BELIEVE THERE ARE A NUMBER OF MATTERS THAT COULD BE IMPLEMENTED VERY QUICKLY, AND AS A RESULT OF OUR PRIOR CONSULTATION, NOT REALLY SUBJECT TO DEBATE.AND WE'LL BRING THOSE MATTERS FORWARD IN THE FALL.WE WILL NEED THE FULL YEAR OF THE INTERIM CONTROL BYLAW TO DEAL WITH THE COMMUNITY ON THE BROADER MATTERS.WE'VE HEARD LOUD AND CLEAR IN CONSULTATIONS WITH THE COMMUNITY THAT THEY WANT TO US LOOK AT A BIGGER ARRAY OF POTENTIAL SOLUTIONS THAN WE INITIALLY PROPOSED, AND WE TAKE THAT INPUT VERY SERIOUSLY. AND WE WANT TO GO BACK AND HAVE THE TIME TO ACTUALLY DO THAT.>> SO WE'LL REPORT -- JUST TO CONCLUDE, WE'LL REPORT IN THE FALL WHEN WE GIVE THAT INTERIM REPORT, WHERE WE STAND MORE BROADLY AND WHERE WE THINK THE TIMELINES ARE AT THAT POINT.>> OKAY.GREAT.THANK YOU.JUST A QUESTION OR TWO TO THE CITY SOLICITOR.I TAKE IT THAT A TRIGGER FOR...I TAKE IT THAT THE TRIGGER FOR, ONCE THIS BYLAW -- ASSUMING THIS BYLAW IS PASSED BY COUNCIL, IF AN APPLICANT HASN'T YET PULLED THE BUILDING PERMIT. IS THAT KIND OF THE THRESHOLD MOMENT IN TIME TO WHICH THIS BYLAW WOULD APPLY?>> MR. CHAIR. THE QUESTION WOULD BE HAS THE APPLICANT CRYSTALLIZED THE BUILDING PERMIT.THERE COMES A POINT IN TIME WHERE THE APPLICANT HAS FILED ABSOLUTELY EVERYTHING THAT IS REQUIRED OF HIM OR HER THAT THE APPLICATION IS CRYSTALLIZED.AND IT IS MY VIEW THAT IT'S AT THAT POINT THEY'D BE ENTITLED TO BALLING PERMIT.IF THEY'RE NOT AT THAT STAGE. THEN THEY WOULD BE CAUGHT BY THE INTERIM CONTROL BYLAW.>> AND MAYBE YOU COULD JUST EXPLAIN A LITTLE BIT.AGAIN.

ASSUMING COUNCIL PASSES THIS BYLAW.IF IT IS APPEALED, I PRESUME THERE'S A RIGHT OF APPEAL ON THE PART OF AN APPLICANT.IS THAT CORRECT?YES?AND SO LET'S ASSUME FOR A MOMENT THAT THE BYLAW IS APPEALED, WHAT IS THE STATUS OF THE BYLAW DURING THE APPEAL PERIOD?>> MR. CHAIR, AS WITH OTHER ZONING BYLAWS, IT REMAINS IN FORCE PENDING THE DETERMINATION OF THE APPEAL.IT REMAINS IN FORCE, MR. CHAIR.>> OKAY.THAT'S IT.THANK YOU VERY MUCH.AND AGAIN, THANK YOU TO STAFF AND TO COLLEAGUES FOR BRINGING THIS FORWARD.>> THANK YOU VERY MUCH.COUNCILOR BROCKINGTON, PLEASE.>> THANK YOU. MR. DEPUTY MAYOR.GIVEN THAT THERE ARE OTHER NEIGHBOURHOODS NOT CAPTURED WITHIN THE ATTACHED MAPS, HOW IS IT DETERMINED WHAT NEIGHBOURHOODS TO EXCLUDE?WHAT NEIGHBOURHOODS TO INCLUDE?>> MR. MAYOR, WE ACTUALLY LOOK A VERY CLOSE LOOK AT WHERE THE ACTIVITY IS WITH RESPECT TO WHAT'S BEEN TERMED AS THE BUNKHOUSE ISSUE.AND WE RECOGNIZE THAT THERE'S OTHER NEIGHBOURHOODS THAT ARE EXPERIENCING VARIOUS CHALLENGES IN TERMS OF IN-FILL AND HOW THAT IN-FILL INTEGRATES WITH THE ESTABLISHED CHARACTER OF THOSE COMMUNITIES. WITHIN THOSE SITUATION, WE DENT FIND THAT THEY WERE IN FACT MEETING SORT OF THE THRESHOLD OF THE BUNKHOUSE ISSUE THAT THE INTERIM CONTROL BYLAW IS REALLY TRYING TO ADDRESS ITSELF TO.HAVING SAID THAT, AS MR. WILLIS INDICATED, AND WITH THE EXPANSION.THE STUDY TO LOOK AT R1, R2, R3 AS WELL.STILL FOCUSING ON SORT OF ENSURING AT THAT WE HAVE THE PROPER RULES IN THE ZONING BYLAW WITH RESPECT TO ENSURING COMPATIBLE INTEGRATION OF NEW DEVELOPMENT WITH THE ESTABLISHED CHARACTERISTICS AND CONDITIONS OF EXISTING COMMUNITIES, WE WILL BE LOOKING AT OTHER AREAS.SO, AREAS THAT MIGHT NOT BE CAPTURED BY THE INTERIM CONTROL ARE NOT EXCLUDED FROM BEING LEADING AT AS PART OF THE BROADER STUDY THAT WE'RE UNDERTAKING.>> I DON'T HAVE BUNKHOUSES. PER SE. BUT I CERTAINLY HAVE IN COPELAND PARK TINY HOMES THAT GET BOUGHT CHEAPER THAN, I GUESS, WHAT THE AVERAGE HOUSE IS GOING FOR IN THE NEIGHBOURHOOD, GET RENOVATED.WE'RE VERY CLOSE TO CARLTON UNIVERSITY.SO WE SEE MULTIPLE STUDENTS COME IN.SO WE DON'T HAVE THE BUNKHOUSE PROPERTY STANDARD TYPE ISSUES, BUT WE HAVE COMPATIBILITY-TYPE OF FRICTION IN THE NEIGHBOURHOOD WHERE YOU HAVE ESTABLISHED COMMUNITIES. YOU HAVE A LARGE QUANTITY OF PEOPLE MOVING INTO THESE SMALLER HOUSES.SO, I'M SATISFIED WITH THE

GEOGRAPHIC ANSWER.JUST -- IT GOES TO ENFORCEMENT.COUNCILOR NUSSBAUM ASKED ABOUT SORT OF THE LEGAL THRESHOLD, BUT WILL THIS JUST FALL ON THE SHOULDERS OF OTTAWA BYLAW TO ENFORCE THAT, IF THERE ARE HOMES THAT BREACH THIS BYLAW, THEY WILL BE CHARGED WITH -- WITH GOING OUT INTO THE COMMUNITY?>> MR. MAYOR, THE SHORT ANSWER TO THE QUESTION IS THIS EFFECTIVELY FREEZES PLANNING APPLICATIONS PENDINGS AS IT RELATES TO THE INTERIM CONTROL BYLAW STUDY AREA. SHOULD THERE BE ANY BREACH OF ZONING MORE GENERALLY. IT ALWAYS DOES GO TO BYLAW ENFORCEMENT, BUT I THINK THIS GETS PICKED UP REALLY WHEN PEOPLE COME IN AND APPLY FOR A BUILDING PERMIT OR WHEN THEY APPLY TO THE COMMITTEE OF ADJUSTMENT OR WHEN THEY APPLY FOR A REZONING APPLICATION. THAT WILL BE THE TRIGGER POINT AT WHICH WE WILL IDENTIFY AND INFORM PEOPLE THAT THERE'S AN INTERIM CONTROL BYLAW IN PLACE.>> BUT MOST PEOPLE DON'T SHOW UP AT CITY HALL AND SAY "I PLAN TO BUILD A BUNKHOUSE."THEY PLAN TO RENOVATE A HOME, AND MAYBE THEIR MOTIVE IS TO MAKE SURE THEY CAN SQUEEZE IN AS MANY PEOPLE, BUT ULTIMATELY, IF NEIGHBOURS REPORT WHAT THEY BELIEVE IS A BUNKHOUSE OR A HOME THAT'S BEING USED INAPPROPRIATELY, IT WILL BE OTTAWA BYLAW THAT DOES THE ENFORCEMENT.>> THAT'S CORRECT.>> OKAY.THANK YOU VERY MUCH.>> DO YOU WANT TO REBUT, COUNCILOR CHIARELLI?NO?OKAY.COUNCILOR BLAIS?>> THANK YOU VERY MUCH.WITH EXTENSION OF LIGHT RAIL, THE CITY AND THE MAYOR AND OTHERS HAVE INDICATED THAT WE BELIEVE THIS WILL EXPAND THE RADIUS THAT STUDENTS FROM -- STUDENTS FROM ALL THE OF TOWN IN PARTICULAR CAN OCCUPY.COULD YOU ANTICIPATE THAT THE NEW RULES THAT COME OUT OF THIS STUDY WOULD APPLY ACROSS THE STUDY OR ONLY TO THESE TWO STUDY AREAS?>> MR. MAYOR, IT'S PREMATURE TO ANSWER THAT QUESTION, BUT I THINK YOUR POINT IS WELL LISTEN TAKEN.THAT WE ACTUALLY HOPE THAT WITH LIGHT RAIL TRANSIT. THIS MIGHT BE PART OF THE SOLUTION. WHERE PEOPLE WOEFUL THEY NEED TO LIVE IN CRAMMED CONDITIONS IMMEDIATELY ON THE DOORSTEP.THAT THEY MAY FIND IT'S VERY CONVENIENT TO LIVE IN OTHER LOCATION, SO WE BELIEVE THAT THAT WILL HELP US.BUT SHOULD THIS ISSUE BE APPARENT THIS IT HAS A BROADER GEE I CAN'T OF COURSE REACH IN THE STUDY THAT MR. SMITH'S TEAM IS DEALING WITH, WE CAN CERTAINLY MAKE THEM CITY-WIDE RULES. SHOULD THAT COME UP AS AN APPROPRIATE CONCLUSION OF THE STUDY.TO YOUR POINT IS TAKEN AND WE'LL TAKE IT UNDER

ADVISEMENT.>> HOW WILL IT COME UP, THOUGH, BECAUSE IF IT'S NOT CURRENTLY A PROBLEM, YOU WANT TO AVOID IT FROM BECOMING ONE, RIGHT?>> MR. MAYOR, WE HAVE DEFINITIONS, DEFINITION CHANGES WILL APPLY LIKELY CITY-WIDE.I DON'T SEE A CIRCUMSTANCE WHERE WE WOULDN'T AND CERTIFY IS CERTAIN OTHER ZONING PROVISIONS MAY COME FORWARD THAT WOULD LIKELY APPLY ACROSS THE ENTIRE ZONE WOULD COME FORWARD. SHOULD OTHER ISSUES COME UP THROUGH THE PUBLIC CONSULTATION TO OUR ATTENTION, WE'LL TAKE A LOOK AT THOSE.>> OKAY.THANK YOU.>> GREAT.THANK YOU.ON THE REPORT...?CARRIED.NEXT MOTION REQUIRING SUSPENSION OF THE RULES BY COUNCILOR DEANS. SECONDED BY COUNCILOR HARDER RESPECTING AIRBNB.ON SUSPENSION.CARRIED.COUNCILOR DEANS, PLEASE.>> THANK YOU, MR. MAYOR.JUST READ THE MOTION FIRST AND THEN I'LL SPEAK TO IT, BUT I MUST SAY THE INTERIM CONTROL BYLAW AND BUNKHOUSES IS A NICE SEGUE INTO WHAT I WANT TO TALK ABOUT.WHEREAS THE CITY'S ZONING BYLAW TWO THOUSAND 8250 AS AMENDED SEEKS TO REGULATE DEVELOPMENT IN RESIDENTIAL ZONES IN A MANNER THAT IS COMPATIBLE WITH EXISTING LAND USE PATTERNS, INCLUDING, FOR EXAMPLE, SO THAT DETACHED DWELLINGS AND THE RESIDENTIAL CHARACTER OF NEIGHBOURHOODS ARE MAINTAINED OR ENHANCED, AND WHEREAS GIVEN THE RECENTLY RECENT ADVENT IN THE USE OF ONLINE PLATFORMS THAT FACILITATE BOOKINGS FOR SHORT-TERM RESIDENTIAL USE IN A VARIETY OF NEIGHBOURHOODS AND ZONES ACROSS THE CITY, AND WHEREAS SUCH USE MAY HAVE AN IMPACT ON RESIDENTIAL NEIGHBOURHOODS INCLUDING THE POTENTIAL FOR INCREASED TRAFFIC, PARKING, NOISE AND RELATED PROPERTY ISSUES AND WHICH MAY HAVE UNINTENDED CONSEQUENCES ON MAINTAINING OR ENHANCING NEIGHBOURHOODS. THEREFORE BE IT RESOLVED THAT CITY COUNCIL DIRECT THE PLANNING, INFRASTRUCTURE AND ECONOMIC DEVELOPMENT DEPARTMENT IN CONSULTATION WITH THE CITY CLERK AND SOLICITOR DEPARTMENT TO REPORT BACK TO PLANNING COMMITTEE BY Q4 2017 WITH AN UPDATE ON THE AVAILABILITY AND EFFECTIVENESS OF EXISTING REGULATORY TOOLS UNDER THE ZONING BYLAW 2008-250 TO ADDRESS COMPLAINTS THAT MAY BE ASSOCIATED WITH SUCH SHORT-TERM USES INCLUDING POTENTIAL CONFLICTING LAND USES.AND I'VE ASKED FOR SUSPENSION SO THAT THE STAFF CAN DO THIS WORK OVER THE SUMMER MONTHS. AND ALTHOUGH THE MOTION WAS WRITTEN TO SAY REPORT BACK IN Q4 2017, I'M ACTUALLY CHANGED THAT TO

SAY "BY Q4."BECAUSE PLANNING DEPARTMENT DOESN'T THINK THAT THIS WILL BE PARTICULARLY ONEROUS AND THEY COULD GET THAT DONE PROBABLY BEFORE Q4 2017.SO JUST TO SPEAK TO IT BRIEFLY...I'M SURE I'M NOT ALONE IN SEEING THE PLETHORA OF CHALLENGING ISSUES THAT ARE ARISING IN OUR NEIGHBOURHOODS AS A RESULT OF AIRBNBS OR OTHER ONLINE PLATFORMS ESTABLISHING IN THE NEIGHBOURHOODS.WHEN THE ZONING BYLAW WAS WRITTEN BACK IN 2008 WE -- OUR WORLD WAS DIFFERENT THEN.WE DIDN'T CONTEMPLATE THE ISSUES THAT MIGHT ARISE BY THESE TYPES OF ONLINE PLATFORMS, AND I CAN TELL YOU I'M DEALING WITH A PARTICULARLY CHALLENGING ONE IN MY WARD RIGHT NOW AND WORKING WITH STAFF FROM BOTH BYLAW SERVICES AND THE LEGAL DEPARTMENT.WE'RE SEEING THAT WE NEED SOME TOOLS TO ADDRESS THIS.SO, AS A STARTING POINT, I THOUGHT IT WOULD BE IMPORTANT TO ASK OUR PLANNING DEPARTMENT AND LEGAL DEPARTMENT TO TAKE A LOOK AT OUR EXISTING ZONING BYLAWS TO SEE IF, PERHAPS, THEY COULD BE MORE BROADLY INTERPRETED TO ADDRESS SOME OF THE ARISING ISSUES PLATFORMS LIKE AIRBNB.SO THIS IS JUST A STARTING POINT.IT'S A REVIEW TO TAKE A LOOK AT THE TOOLS THAT WE HAVE AND SEE IF, PERHAPS, A NEW INTERPRETATION WAS PUT ON THOSE RULES, IF THEY WOULD GIVE US THE TOOLS THAT WE NEED TO ADEQUATELY ADDRESS THE EMERGING ISSUE.SO THAT'S WHAT THE MOTION DOES, MR. MAYOR.>> THANK YOU, COUNCILOR DEANS.COUNCILOR CHIARELLI, PLEASE.>> THANK YOU, YOUR WORSHIP.I'M GLAD TO SEE THIS COME FORWARD, BECAUSE IN OUR WARD, WE'RE GETTING A NUMBER OF PEOPLE NOW WHO ARE UPSET THAT, YOU KNOW, THEY HAVE A RESIDENTIAL NEIGHBOURHOOD THAT WAS NOT SUPPOSED TO BE A NEIGHBOURHOOD OF HOTELS, AND, YOU KNOW, WHEN STUDENTS GO AWAY FROM STUDENT HOUSING IN THE SPRING TO RETURN IN THE FALL, THERE'S A GAP WHERE PEOPLE ARE TRYING TO -- BE OPPORTUNISTIC AND TURN INDIVIDUAL RESIDENCES INTO MINI HOTELS. AND THIS IS A CONCERN TO PEOPLE LIVING IN THE COMMUNITY.SO, I GUESS THE MESSAGE IS JUST BECAUSE YOU HAVE A TECHNOLOGY THAT LETS YOU DO SOMETHING THAT IS CURRENTLY NOT LEGAL, THAT -- THE FACT THAT YOU CAN DO IT BY TECHNOLOGY DOESN'T CHANGE THE LAW.AND WE WILL CHANGE THE LAW ONE WAY OR ANOTHER, I THINK, IN A WAY THAT WILL BEST-PROTECT OUR COMMUNITIES.BUT I THINK THERE'S AN ASSUMPTION SOMETIMES THAT BECAUSE A NEW TECHNOLOGY LETS YOU DO SOMETHING, THEREFORE, THE LAWS THAT WOULD HAVE PREVENTED IT OTHERWISE NO LONGER APPLY.AND
